

ORDINANCE NO. 04-25

AN ORDINANCE AMENDING ORDINANCE NO. 04-24 DATED SEPTEMBER 9, 2024, WHICH IS AN ORDINANCE SETTING WATER & SEWER RATES FOR CUSTOMERS OF THE CITY OF STRAWN, INSIDE AND OUTSIDE THE CITY LIMITS OF THE CITY OF STRAWN; SETTING THE WATER & SEWER TAP RATES (WITH THE EXCEPTION OF RURAL CUSTOMERS' WATER TAP RATES SET BY CONTRACT); PROVIDING THAT NO FREE SERVICE OF USE OF THE FACILITIES WILL BE PERMITTED; PROVIDING FOR THE MANDATORY USE OF THE FACILITIES IF AND WHEN AVAILABLE; PROVIDING FOR ONE HOOK-UP PER METER; SETTING WATER METER DEPOSITS AND REFUND THEREOF UPON TERMINATION OF SERVICE; PROVIDING FOR CHARGING OF LATE CHARGES ON DELINQUENT ACCOUNTS, AND PROVIDING FOR ADDITIONAL PENALTIES, INCLUDING RE-CONNECT FEES; NEW ACCOUNTS; SETTING RATES FOR MACHINE WORK; PROVIDING THAT THIS ORDINANCE SHALL AMEND EVERY PRIOR ORDINANCE IN CONFLICT HEREWITH; AND SHALL BE ACCUMULATIVE OF ALL PRIOR ORDINANCES NOT IN DIRECT CONFLICT; AND NAMING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF STRAWN, TEXAS:

SECTION I

The rates and charges for water and sewer services are hereby established as follows:

RESIDENTIAL WATER RATES

Each Water Connection inside city limits\$52.48 Minimum

1 to 15,000 gallons

Used per month per meter inside city limits.....\$10.55per 1,000 gallons

15,001 gallons and over per month per meter inside city limits.....\$12.34 per 1,000 gallons

Each Water Connection outside city limits.....\$63.03 Minimum

1 to 15,000 gallons

Used per month per meter outside city limits.....\$12.34 per 1,000 gallons

15,001 gallons and over per month per meter outside city limits.....\$14.02 per 1,000 gallons

COMMERCIAL WATER RATES

Each Water Connection inside city limits 3/4 " Meter.....\$56.70 Minimum

Each Water Connection inside city limits 2" Meter\$200.00 Minimum

1 to 15,000 gallons

Used per month per meter inside city limits.....\$10.71 per 1,000 gallons

15,001 gallons and over per month per meter inside city limits.....\$12.45 per 1,000 gallons

Each Water Connection outside city limits.....\$69.88 Minimum

1 to 15,000 gallons

Used per month per meter outside city limits.....\$12.34 per 1,000 gallons

15,001 and over per month per meter outside city limits.....\$13.92 per 1,000 gallons

UNMETERED WATER RATES

Bulk Water Rate – Treated Water Residential.....\$14.00 per 1,000 gallons

Bulk Water Rate-Treated Water Commercial.....\$25.00 per 1,000 gallons

Bulk Water Rate – Untreated Water.....\$ 9.00 per 1,000 gallons

RESIDENTIAL SEWER RATES

Each Sewer Connection\$19.46 Minimum

1 to 30,000 gallons water used per month.....Minimum plus \$2.87 per
1,000 gallons
\$105.56 MAXIMUM

COMMERCIAL SEWER RATES

Each Sewer Connection.....\$22.10 Minimum

1 to 30,000 gallons water used per month.....Minimum plus \$2.87 per
1,000 gallons
\$108.20 MAXIMUM

SECTION II

The rates and charges for water and sewer taps are hereby established as follows:

Water Tap $\frac{3}{4}$ inch (Residential and Commercial).....	\$3000.00 per tap within City Limits
Water Tap $\frac{3}{4}$ inch (Residential and Commercial).....	\$4000.00 per tap outside City Limits
Water tap for a 1-inch meter	\$4000.00 per tap
Water Tap for 2-inch meter.....	\$5000.00 per tap
Water Tap outside City Limits to be determined by circumstance on each line and will reflect actual cost to install.	
Sewer Tap (Residential and Commercial)	\$3000.00 per tap

All new irrigation systems require a Reduce Pressure Valve installed at the customer's expense. This device must be tested annually by an appropriately licensed individual at the customer's expense. The results of this test must be furnished to the City of Strawn. Failure to comply will result in disconnection of service.

All new Commercial Meters require a Reduce Pressure Valve installed at the customer's expense. This device must be tested annually by an appropriately licensed individual at the customer's expense. The results of this test must be furnished to the City of Strawn. Failure to comply will result in disconnection of service.

SECTION III

No free service or use of these facilities will be permitted.

SECTION IV

Mandatory use of facilities will be enforced to all customers to whom service is available, and if and when service is available in the future.

SECTION V

Only one (1) hook-up per meter will be allowed. A tap and meter will be required for additional residences or other buildings located on the same property, or adjacent property, and the required fees shall be paid. Each meter will be billed separately at the established rate for service.

SECTION VI

METER ACTIVATION FEE

Going forward no Deposits will be required to open a new account. In lieu of a deposit, a \$50.00 activation fee will be charged for each account opened.

SECTION VII

DELINQUENT ACCOUNTS

The following rules will govern all water user accounts:

1. All bills are due and payable on or before the 10th of the month following receipt of bill
2. If account is not paid by the 10th of the month following receipt of the bill, a late fee of \$10.00 will be added to the bill.
3. Water service will automatically be terminated AND METER LOCKED or REMOVED if account remains delinquent twenty-one (21) days after the due date, unless payment arrangements are made with the City Secretary and an agreement signed.

SECTION VIII

RE-CONNECT

1. In the event of removal of the meter, customer will be assessed a deposit of Two-Hundred (\$200.00) Dollars, plus a re-connect fee of Fifty (\$50.00) Dollars, plus the balance of outstanding bill not covered by original deposit consumed by the past due account.
2. No action on re-connect will be taken other than during regular City business hours, and all fees must be collected prior to said action.

SECTION IX

REQUIREMENTS FOR TRAPS

1. Discharges requiring a trap include:
 - (a) Grease or waste containing grease in excessive amounts;
 - (b) Oil;
 - (c) Sand;
 - (d) Flammable wastes; and
 - (e) Other harmful ingredients.
2. Any person responsible for discharges requiring a trap shall, at his own expense and as required by the approving authority:
 - (a) Provide equipment and facilities of a type and capacity approved by the approving authority;

- (b) Locate the trap in a manner that provides ready and easy accessibility for cleaning and inspection; and
- (c) Maintain the trap in effective operating condition.

SECTION X

NOTIFICATION

1. Notification of past due accounts and the balances will be printed on the water bill.

SECTION XI

NEW ACCOUNTS

1. All new requests for water service will be subject to credit check of the applicant of past utility accounts.

SECTION XII

The following rates will apply to hourly rates for machinery and operator:

Machine and operator.....\$100.00 per hour (2 Hour minimum)

Mowing (Brush-hog or Lawn Mower).....\$75.00 per hour (2 hour minimum)

SECTION XII

This ordinance shall and does amend every prior ordinance in conflict herewith, but as to all other ordinances or sections of ordinances not in direct conflict, this ordinance shall be, and the same is hereby made cumulative.

SECTION XIII

This ordinance numbered **04-25** shall be in full force and effective October 1, 2025.
