FINAL PUBLIC HEARING

Welcome to the final public hearing to be held as required by the Texas Community Development Block Grant Program Funds (TxCDBG).

We encourage your participation and, specifically, participation by persons of low and moderate income residing in slum and blight areas and in areas in which TxCDBG funds were used. We hold these public hearings to obtain citizens' views and respond to questions, proposals, and comments at all stages of the community development program.

This final public hearing is to present to you the specifics of the project recently completed. After the review of the project today, we will ask for your comments and questions regarding the program performance.

The TxCDBG project has been completed.

Type of Project: 2021 CDBG Downtown Revitalization Project funded by HUD/TDA, Contract CDM21-0314

Activity Completed: Contractor reconstructed and installed approximately nine hundred seventy one linear feet (971 l.f.) of concrete sidewalk, eight hundred forty linear feet (840 l.f.) of curb and gutter, fourteen (14) ADA ramps, two hundred seventy four linear feet (274 l.f.) of handrail, installed eleven (eleven) pedestrian lights and electrical components, pavement repair, and all associated appurtenances along Central Avenue and Housley Street.

Funds Spent: \$346,792.66 in Grant Funds, \$52,018.90 in Match Funds. Total Project: \$398,811.56

Contractor: C. Green Scaping

Engineer: Jacob & Martin

Grant Admin Consultant: Public Management, Inc.

Project Beneficiaries – (at time of application) 535 persons, of which 280, or 52.34% are low to moderate income.
